Important Books on Peacemaking

The following books provide an excellent overview of the theology and practice of peacemaking, and the multi-dimensional nature of reconciliation.

Augsburger, David W.

1992 Conflict Mediation Across Cultures: Pathways and Patterns

Louisville: Westminster/John Knox Press

Full of helpful case studies and wise insights about peacemaking, especially across cultures. At times a bit academic.

Daye, Russell

2004 Political Forgiveness: Lessons from South Africa

Maryknoll: Orbis Books

As the title suggests, Daye seeks to learn lessons from South Africa about the role of forgiveness in the political sphere. He describes five acts of political forgiveness: truth-telling, apology and claiming of responsibility, building a transitional-justice framework, finding ways to heal, and embracing forgiveness.

Elmer, Duane

1993 Cross-Cultural Conflict: Building Relationships for Effective Ministry

Downers Grove: InterVarsity Press

The best book available on peacemaking cross-culturally. Describes Biblically acceptable and culturally sensitive alternatives to the more direct Western approach to peacemaking. Discussion on the role of a mediator, storytelling, proverbs and the understanding of a shame culture is exceptional.

Fisher, Roger and William Ury

1991 Getting to Yes: Negotiating Agreement Without Giving In (2nd edition)

New York: Penguin

A standard work on business negotiation with profound relevance for peacemaking. Describes four keys to "principled negotiation" – separate the people from the problem, focus on interests rather than positions, generate a variety of possibilities before deciding what to do, insist that the result be based on some objective standard (criteria).

2008 Forgiveness: Breaking the Chain of Hate

Abundantly illustrates the healing power of forgiveness through case studies from around the world. A stirring, inspirational book that will help equip the next generation of peacemakers.

A simple and friendly faith exchange between a Muslim and a Christian. A great example of dialogue without compromise. David Shenk's irenic spirit shines throughout.

2008 Reconciling All Things: A Christian Vision for Justice, Peace and Healing

A profoundly biblical description of reconciliation in all its fullness. At the same time clear about the painful realism of the world in which we pursue peace. The authors are co-directors of the Center for Reconciliation at Duke Divinity School.

1992 The Peacemaker: A Biblical Guide to Resolving Personal Conflict

An excellent, comprehensive, practical guide to peacemaking. As a lawyer, however, Sande tends to put a great emphasis on the more legal dimensions of the process rather than the pastoral.

Stassen, Glen H.

1992 Just Peacemaking: Transforming Initiatives for Justice and Peace.

Louisville: Westminster/John Knox Press

Outlines the basic principles of "just peacemaking," with a profound analysis of the Sermon on the Mount. Stassen is a professor of Christian ethics at Fuller Theological Seminary.

2004 Just Peacemaking: Ten Practices for Abolishing War

Cleveland: The Pilgrim Press

Glen Stassen and others describe a new kind of ethical theory as it relates to war, which they call "just peacemaking." In contrast to pacifism and just war theory, just peacemaking focuses on the importance of ten proactive practices that prevent war and facilitate peace.

Tutu, Desmond

2000 No Future Without Forgiveness

New York: Image Doubleday

A profoundly moving story along with revolting details about apartheid in South Africa. Describes the Truth and Reconciliation Commission and the role of forgiveness in the healing of this nation. Tutu's commitment to "restorative justice ... the healing of breaches, the redressing of imbalances, the restoration of broken relationships" highlights the power of true forgiveness.

Volf, Miroslav

1996 Exclusion and Embrace: A Theological Exploration of Identity, Otherness, and Reconciliation Nashville: Abingdon Press

A profound description of reconciliation by a world class theologian. But this is not ivory tower theology. It was born in the crucible of violence and war. Not always an easy read.

2005 Free of Charge: Giving and Forgiving in a Culture Stripped of Grace

Zondervan: Grand Rapids

A popular yet profound description of the theology of giving and forgiving. Volf is masterful at showing how the gospel of Jesus relates to life.
